



Goal of COPN Accelerator 4.0:

Strengthen the capacity of California communities to embed health equity principles and practices in their response to fentanyl and other drugs.

Examples of Health Equity Strategies:

- **Cultivating new partnerships** with local CBOs and amplifying the voice of people with lived experience
- Integrating trauma-informed practices within local organizations and systems
- Identifying and addressing stigma surrounding substance use disorder, substance use, and treatment
- Recognizing and building ties with economic and racial justice organizations and/or movements

Our Accelerator program model for preventing overdose deaths and creating long-term, sustainable systems change









Program Overview

PHASE 1: "Call to Action"

- Define health equity for your community
- Identify historical challenges
- Hear from leaders in CA and communities from other states
- Understand disparity data
- Set a big picture goal
- Learn new strategies
- Create a "call to action"

PHASE 2: "Equity in Action"

- Conduct an applied equity project
- Apply strategies for meaningful community engagement
- Get feedback and insights from subject matter experts
- Integrate continuous quality improvement (CQI) strategies
- Begin shifting local narratives and use resiliency framing







Program Components

- Monthly virtual workshops
- Monthly virtual learning groups facilitated by an Impact Coach
- Customized tools and resources
- Online program portal
- Two virtual convenings
- Applied equity project with support from subject matter experts and a \$10,000 stipend







What should my team look like?

- 4-6 representatives of a new or existing collaborative or coalition (formal or informal)
- Multi-sector
- Serves a city or county (possible regional teams with program office permission)
- Addressing substance use and/or overdose in some capacity
- Identified Team Coordinator
- Does NOT include an AmeriCorps VISTA member









Expectations

- Year long commitment: October 2022 Sept 2023
- 5-6 hours per month (for each/all team member)
- Participation in all program activities including:
- Monthly workshops
- Team-based tools
- Monthly learning group calls facilitated by impact coach
- Biannual convenings
- Applied health equity project











COPN AmeriCorps VISTA Program

Largest overdose prevention VISTA project in the country

2 VISTA Leads and 40 slots for AmeriCorps members in the field

Only teams that have NOT received an AmeriCorps member in the past need to apply






Application Timeline

- Application due: Friday, September 30, 2022
- Teams notified of selection: October 10, 2022
- Program Launch: Tuesday, October 25, 2-4 PM
